



## GLENELG PEDAL BAR LIABILITY WAIVER

I, the undersigned, acknowledge and understand that participating on the "Glenelg Pedal Bar" there is possible risk of injury. I understand the risk that I may be injured and/or injure someone else while using the Glenelg Pedal Bar. I understand and voluntarily accept all risks associated with my participation on the pedal bar as well as all risk of loss, theft or damage of personal property while using or present on the pedal bar or at the establishments/ locations where the tour may visit. My participation in this activity is purely voluntary and I elect to participate in spite of the risks. I release and waive any claims or action against Glenelg Pedal Bar, its employees, owners, their affiliates, subsidiaries, successors or assigns for any personal injury, property loss, or property damage, including any action for negligence, products liability or strict liability, and hereby forever waive the right to bring any such action.

I also agree that Glenelg Pedal Bar is not responsible for the conduct of other persons or the conditions of any biking surface.

I have read and agree to abide by the rules set forth by the owners and operators of the Glenelg Pedal Bar.

1. All riders that consume alcohol must be 18 years of age or older
2. All alcoholic beverages and people holding them must remain on the Glenelg Pedal Bar at all times.
3. Any person arriving in an intoxicated condition shall not be allowed to board the Glenelg Pedal Bar.
4. All laws and rules regarding alcohol and behaviour apply to all passengers before, during and after the Glenelg Pedal bar tours. Inappropriate behaviour will result in the offending passenger(s) being asked to disembark immediately. NO refund will be issued to passenger(s) asked to disembark by the driver and the driver's decisions are final. Inappropriate behaviour includes but is not limited to:
  - . Intoxication
  - . Consuming or taking alcohol (provided by the Glenelg Pedal Bar) off the bike
  - . Public Urination/vomiting
  - . Bringing own beverages and drinking them on the tour
  - . Excessive noise/screaming
  - . Littering
  - . Loitering after the tour
5. Hold on at all times whilst bike is moving.
6. I agree to abide with the driver's instructions and will not harass the driver or interfere with the driver's operation of the vehicle at any time. Any harassment or dangerous situation created by a rider will be the cause of immediate ejection.
